5. THAT I acknowledge that the property is subject to a building restriction caveat enforced by Policy 11/2012 as attached.



POLICY 11/2012

A POLICY RESPECTING THE PENALTY ON NOT BUILDING IN 3 YEARS

The Resort Village of Chitek Lake has approved a policy as follows respecting the penalty on not building within 3 years as per the signed agreement from the original purchaser from the Resort Village of Chitek Lake and the Resort Village of Chitek Lake.

1. The current owner will be invoiced on the anniversary date for the previous year.  
Example anniversary date July, 2006, the first invoice will be for not building from July, 2006 to July, 2009 due within 90 days. The second invoice will be from July, 2009 to July, 2010 etc.
2. The owner of the property will notify the village office in writing when the residence is 90% complete to arrange for an inspection, or the invoicing will be valid and must be paid.
3. Council will be responsible for having the residence inspected and will notify the current owner of the residence that the residence meets the requirement and the caveat will be removed.
